## **Declaration according to regulation (EC) No. 1907/2006 (REACH)**

Regulation (EC) No. 1907/2006 addresses the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH). It deals with the handling of chemical substances in mixtures (preparations) and articles. The objective is a consistent traceability of applied chemical substances from fabrication to final application.

W. Köpp GmbH & Co. KG performs as a downstream user. Our products are considered as articles and not as chemical substances. Hence, they are not obligatory to registration. There is either no need for registration for chemical substances or an applied article is already registered by our supplier (producer or importer).

Our articles do not release chemical substances under normal and reasonable foreseen conditions of use (see Article 7(1)).

## **Declaration according to Article 33(1) of regulation (EC) No. 1907/2006**

We hereby declare that W. Köpp GmbH & Co. KG is currently not applying any chemical substance with a concentration higher than 0.1 wt% in our articles which is a candidate for the list of substances of very high concern for authorisation from the European Chemicals Agency ECHA (in accordance with article 59(10)). An exception here is constituted by our HFFR, FR and VMQ-qualities.
