Declaration of Conformity (RoHS)

To the Directive 2011/65/EU of the European Parliament and the Council of 08 June 2011, which restricts the use of certain hazardous substances in electrical and electronic equipment.

This is to confirm that all current Cellrubber and Azote brand foam products (incorporating all Plastazote®, Evazote®, Supazote® and Propozote® grades) and Zotek brand products (incorporating all Zotek® F and Zotek® N grades), Polytetrafluorethylen (PTFE) and VYON/GURON- products, additionally all other filter products we sell, are fully compliant with the requirements of the EC directive.

In particular, we point out, that none of the substances listed in the table below were used intentionally, or are included in Amounts above the permissible limits for the Qualities and Products mentioned above, during any time during the production and Work Processes of the Köpp Company.

Annex II - RoHS-Directive [(EU) 2015/863]

In the Official EU Release from 4 June 2015 amending the RoHS Directive [(EU) 2015/863] which was re-formulated Annex II of the RoHS Directive to ensure that the 6 substances listed on page 1 will be extend to include the four substances listed in the table below.

This is to additional confirm that all current Cellrubber and Azote brand foam products (incorporating all Plastazote®, Evazote®, Supazote® and Propozote® grades) and Zotek brand products (incorporating all Zotek® F and Zotek® N grades), Polytetrafluorethylen (PTFE) and VYON/GURON- products, additionally all other filter products we sell, are fully compliant with the requirements in Annex II of the EU Directive.

The four new banned substances apply as of 22 July 2019. This period shall be extended by two additional years, specifically for medical devices as well as monitoring and control instruments, i.e. for these devices the new substance bans apply as of 22 July 2021. There are exceptions, such as in the RoHS Directive for common spare parts for equipment that have been placed on the market before the above mentioned dates.

All listed material bans do not apply to electrical and electronic equipment as a whole but to each homogenous material of the device (eg. As in a plastic case). Manufacturers of such devices must ensure that their Products comply with the material bans.
